Corepay / Visa VIRP / Mastercard BRAM Onboarding Support Document

1. Purpose of this Declaration

This Merchant Compliance Disclosure & Prohibited Content Declaration is issued by DRIVEX STUDIOS SL (“DriveX Studios”, “DriveX”, “we”, “our” or “us”) in connection with its onboarding as an adult-content merchant for card-payment processing.

This document is intended to provide a clear written declaration regarding:

This document supports compliance with Corepay onboarding requirements, Visa VIRP expectations, Mastercard BRAM expectations, acquiring-bank review requirements and payment-processor risk-management standards.

DriveX Studios undertakes not to process payments through undisclosed URLs without prior notification and approval where required.

DriveX Studios shall disclose to Corepay and relevant payment partners any free, affiliate, promotional or related websites that:

- promote the same content;
- redirect to the Platform;
- share revenue;
- share branding;
- share user flows;
- generate traffic for paid services;
- host promotional or preview content connected to DriveX Studios.

Any additional related websites shall be communicated prior to commercial use or payment-processing integration where required.

DriveX Studios undertakes to keep customer service information accurate, visible and accessible on the Platform.

6. Merchant Billing Descriptor

DriveX Studios undertakes to display a clear merchant billing descriptor on the Platform, including at or before checkout where technically feasible.

The billing descriptor shall be communicated in a manner allowing users to recognize charges related to DriveX Studios services.

DriveX Studios shall coordinate the final descriptor with Corepay, the payment processor and the acquiring bank.

The billing descriptor shall not be misleading and shall be reasonably aligned with the Platform identity.

7. Adult-Only Platform Declaration

DriveX Studios declares that access to adult-oriented content and services is strictly limited to individuals who are at least eighteen (18) years old.

DriveX Studios implements or intends to implement appropriate age-verification, identity-verification, access-control and compliance measures intended to restrict access by minors and protect platform integrity.

8. Professional-Only Content Declaration

DriveX Studios declares that it operates as a professional adult audiovisual platform.

DriveX Studios does not permit:

- anonymous adult-content uploads;
- unrestricted user-generated adult content;
- unverified amateur uploads;
- publication without prior compliance review.

Only verified professional content providers, studios, distributors, rights holders, agencies or authorized commercial partners may provide content through the Platform.

9. Card-Scheme Prohibited Content Confirmation

DriveX Studios confirms that it does not permit and shall not knowingly process payments for content involving any of the following categories:

9.1 CSAM and Minors

DriveX Studios confirms that it prohibits:

- Child Sexual Abuse Material (“CSAM”);
- any content involving minors;
- any content depicting minors in sexual or suggestive contexts;
- simulated minors;
- sexualized youth depictions.

9.2 Incest and Related Themes

DriveX Studios confirms that it prohibits:

- incest content;
- incest-themed content;
- simulated incest themes where prohibited by card-scheme rules or payment-compliance requirements.

9.3 Bestiality and Animal Abuse

DriveX Studios confirms that it prohibits:

- bestiality;
- animal sexual abuse;
- animal cruelty or abuse content.

9.4 Rape and Non-Consensual Sexual Acts

DriveX Studios confirms that it prohibits:

- rape content;
- non-consensual sexual acts;
- coercive sexual conduct;
- forced sexual activity;
- content depicting persons unable to consent.

9.5 Non-Consensual Intimate Imagery and Deepfakes

DriveX Studios confirms that it prohibits:

- non-consensual intimate imagery;
- revenge pornography;
- hidden-camera sexual content;
- unauthorized sexual deepfakes;
- synthetic sexual impersonation without valid consent.

9.6 Escort Services and Prostitution

DriveX Studios confirms that it prohibits:

- escort services;
- prostitution;
- promotion or advertising of escort or prostitution services;
- solicitation of unlawful sexual services;
- facilitation of unlawful physical encounters.

9.7 Human Trafficking and Physical Abuse

DriveX Studios confirms that it prohibits:

- human trafficking;
- sex trafficking;
- exploitation;
- physical abuse;
- coercion;
- forced participation;
- content involving vulnerable persons exploited unlawfully.

9.8 Prohibited Marketing and Search Terms

DriveX Studios confirms that it prohibits:

- marketing suggesting prohibited content categories;
- metadata designed to imply prohibited content;
- tags, keywords or promotional language connected to card-scheme prohibited content;
- deceptive or unlawful traffic-generation practices.

9.9 Illegal or Harmful Content

DriveX Studios confirms that it prohibits:

- illegal content under applicable laws;
 - harmful or exploitative content;
 - content violating payment-processor rules;
 - content violating Visa or Mastercard standards;
 - content violating DriveX Studios' internal policies.

11. Monitoring and Enforcement Commitment

- cooperate with payment processors, acquiring banks and card networks.

DriveX Studios may apply pre-publication review, post-publication monitoring, user reporting, compliance investigations and emergency escalation procedures.

12. Cooperation with Corepay, Acquiring Banks and Card Networks

DriveX Studios undertakes to cooperate in good faith with Corepay, payment processors, acquiring banks and card networks in connection with:

- onboarding review;
 - website review;
 - content review;
 - periodic compliance checks;
 - risk monitoring;
 - fraud or chargeback inquiries;
 - prohibited-content investigations;
 - regulatory or card-scheme compliance requests.

13. Reservation of Rights

Nothing in this declaration shall limit DriveX Studios' rights to:

- update its policies;
 - amend compliance procedures;
 - implement stricter controls;
 - suspend access;
 - reject content;
 - terminate relationships;
 - preserve evidence;
 - comply with legal obligations.
