DriveX reserves the right to carry out any necessary checks before, during and after the selection of the winner. Any participant suspected of fraud, even partially, may:

- or any direct or indirect damage resulting from the use of the vehicle after its transfer.

The winner expressly acknowledges that the vehicles offered in the Contest may feature:

- high powers;
- specific preparations;
- sporty road handling;
- and require careful and appropriate driving.

DriveX reserves the right to refuse or temporarily suspend the handover of the vehicle in the event of:

- serious doubt as to the identity of the winner;
- lack of a valid driver's license;
- manifest incapacity;
- dangerous behaviour;
- drunkenness;
- suspicion of fraud;
- or any other situation that could reasonably give rise to liability on the part of the Promoter.

In a desire to be benevolent and flexible towards the winners, DriveX will also be able to offer, without obligation on its part, a solution for immediate buyback of the vehicle won.

In this case:

- a separate agreement will be drawn up;
- the redemption value will be freely determined by DriveX;

## **SECTION 22 — OFFICIAL VERSION OF THE REGULATIONS**

These Rules may be translated into different languages.

In the event of a contradiction, divergence of interpretation or difference between several language versions:

- the Spanish version of the Rules shall prevail;
  - and will be the only legal authority before the competent Spanish authorities and courts.

## **SECTION 23 — FILING AND RETENTION OF BY-LAW**

These rules may be:

- filed with a Spanish notary;
- annexed to a notarial deed;
- time-stamped;

- electronically archived;
- or kept by any means to guarantee its integrity and date.

DriveX reserves the right to produce these rules, their annexes and any updates:

- with the authorities;
- the courts;
- banking partners;
- payment providers;
- or the competent inspection bodies.

## **ARTICLE 24 – OVERALL ACCEPTANCE AND INDIVISIBILITY**

The participant acknowledges that he or she has read all of these rules before participating in the competition.

If any clause of these rules is declared null, unenforceable or invalid, the other provisions shall remain fully applicable.
